THE SETTLEMENT GUIDELINES FOR THE PLAGIARISM CONDUCTED BY
THE ACADEMIC CIVITAS OF UNIVERSITAS INDONESIA

THE RECTOR OF UNIVERSITAS INDONESIA,

- Considering:
- a. that at the University community, particularly for each Academic *Civitas*, the principle of honesty in scientific work writing has to be upheld and become the guideline of life, thus plagiarism can never be justified;
 - b. that stating the sources of references is the scientific behavior that shows, appreciates, and respects other people's scientific works as well as acknowledges the rights on their works without reducing the integrity and dignity of the relevant scientists;
 - c. that to solve the plagiarism conducted by the Academic *Civitas* of Universitas Indonesia, it is necessary to develop guidelines that are stipulated by the Rector Decree of Universitas Indonesia;

DECIDES:

To stipulate: THE RECTOR DECREE OF UNIVERSITAS INDONESIA ON THE SETTLEMENT GUIDELINES FOR THE PLAGIARISM CONDUCTED BY THE ACADEMIC CIVITAS OF UNIVERSITAS INDONESIA

CHAPTER I GENERAL PROVISIONS

Article 1

In this Rector Decree, the terms referred to as:

1. Plagiarism is someone's act of stealing other people's idea or thought that has been put in written form and/or other people's writing and what they have used in their writing as if other people's idea or writing is that someone's own idea, thought and/or writing, and thus inflicting a disservice to other people materially as well as non-materially, it can be in the form of stealing a word, phrase, sentence, paragraph, or even chapter from someone's writing or book, without stating the source, included in the definition of Plagiarism is self-Plagiarism.
2. Self-Plagiarism is someone's act in repeatedly using idea or thought that has been put in written form and/or their own writing partially or completely without stating the source of first publication, so it seems that the idea, thought and/or writing is new and advantageous to oneself.
3. The reported person is an Academic *Civitas* of Universitas Indonesia that has been reported of conducting plagiarism.
4. The reporting person is someone that reports the supposition of a Plagiarism conducted by an Academic *Civitas* of Universitas Indonesia.
5. University is Universitas Indonesia as a State-owned Legal Entity.
6. Academic *Civitas* is the Academic Personnel of Universitas Indonesia and the Students of Universitas Indonesia.
